- (i) The candidate must complete his/her MBBS course in $4\frac{1}{2}$ years. If he/she fails to do so, he/she shall pay $\frac{1}{2}$ (half) amount of the tuition fee determined every 6 month as an additional tuition fee till he/she passes Final Prof. Part II University Examination.
- (ii) As per the Judgement passed by the Hon'ble Supreme Court of India, in the matter of Islamic Academy of Education and Another V/s State of Karnataka & Others (Writ Petition Civil No. 350 of 1993) in its judgement dated 14.08.2003, all candidates who obtain admission in the Shri Guru Ram Rai Institute of Medical & Health Sciences, Dehradun shall be required to submit an affidavit that he/she shall not withdraw his/her candidature after the last date of admission and under no circumstances tuition fee shall be refunded.
