Shri Guru Ram Rai Institute of Medical & Health Sciences, Patel Nagar, Dehradun is a constituent college of Shri Guru Ram Rai University.

Presently, Shri Guru Ram Rai Institute of Medical & Health Science, constituent college of Shri Guru Ram Rai University is charging tuition fee from the students as per the fee order displayed on the HNB Uttarakhand Medical Education University website, and the college had challenged the said Govt. Order in the Hon'ble High Court of Uttarakhand in the Writ Petition (M/S) No. 933 of 2018. The college and admitted students of SGRRIM&HS shall abide by the final outcome of the WP No. 933 of 2018.

As the interim direction passed by the Hon'ble High Court of Uttarakhand in the WPMS no. 1059,1064,1065,1066 & others of 2018, students have to submit an undertaking that they shall abide by the final outcome of the writ petition (M/S) No. 933 of 2018.

As per the Judgement passed by the Hon'ble Supreme Court of India, in the matter of Islamic Academy of Education and Another V/s State of Karnataka & Others (Writ Petition Civil No. 350 of 1993) in its judgement dated 14.08.2003, all candidates who obtain admission in the Shri Guru Ram Rai Institute of Medical & Health Sciences shall be required to submit an affidavit at the time of joining that he/she shall not withdraw his/her candidature after last date of admission; failing which he/she shall be required to pay tuition fee according to the final outcome of the WPMS No. 933 of 2018 for the entire duration of the course.
