

## Instructions for candidates applying through NEET (U.G.) 2023 Counseling

Admission to MBBS course at our institution SGRRIM&HS for academic session 2023-24 shall be through State centralized counseling. For counseling and registration candidate must visit [www.hnbumu.ac.in](http://www.hnbumu.ac.in).

**Candidates who are allotted MBBS seat in SGRRIM&HS and willing to join should follow the following procedure – Directions for Admission:**

Step 1	Login to <a href="https://meta-secure.com/HNBUMU_NEETUG">https://meta-secure.com/HNBUMU_NEETUG</a> (website) with your login ID.
Step 2	Pay the advance tuition fee of Rs. 9,00,000/- (Rupees Nine Lakhs).
Step 3	Download advance tuition fee receipt online using your login ID. Download the fee receipt.
Step 4	Download allotment letter using your login ID.
Step 5	Pay the balance fee of college Rs. 17,00,800/- (Rupees Seventeen Lakhs Eight Hundred). <b>(For Both State Quota &amp; All India Management Quota)</b>
Step 6	Report to the college with tuition fee receipt and UTR number or DD of Rs. 17,00,800/- Plus other required documents enlisted below.
Step 7	Collect your admission letter from the college after Document and fee verification.

**Note: The 26% rebate in tuition fee will be given to 30% students (45 seats) after the last date of admission and on completion of the admission process. The excess amount deposited at the time of admission will be adjusted in the 2<sup>nd</sup> year fee.**

1. For Admission in MBBS courses, 30% seats shall be reserved for the permanent residents of the State of Uttarakhand as per SGRRU act no. 33 (1) – For admission in all courses conducted by the University, 30% seats shall be reserved for the permanent residents of the State of Uttarakhand, and if the reserved seats are vacant then the said vacant seats may be filled by other students.
2. 26% rebate on Tuition fee is given to the permanent resident of Uttarakhand as mentioned in SGRRU act no. 33(2).
3. For 30% reserved seats for permanent resident of State of Uttarakhand the University shall comply with State Government reservation Policy as amended applicable from time to time as per SGRRU act 33(4).
4. So out of total 150 seats, 45 seats are reserved for permanent resident of State of Uttarakhand, if the reserved seats are vacant then the said vacant seats may be filled by the other students. 105 seats are for other candidates.

(i) The candidate must complete his/her MBBS course in 4 ½ years. If he/she fails to do so, he/she shall pay ½ (half) amount of the tuition fee determined every 6 month as an additional tuition fee till he/she passes Final Prof. Part - II University Examination.

(ii) As per the Judgement passed by the Hon'ble Supreme Court of India, in the matter of Islamic Academy of Education and Another V/s State of Karnataka & Others (Writ Petition Civil No. 350 of 1993) in its judgement dated 14.08.2003, all candidates who obtain admission in the Shri Guru Ram Rai Institute of Medical & Health Sciences, Dehradun shall be required to submit an affidavit that he/she shall not withdraw his/her candidature after the last date of admission and under no circumstances tuition fee shall be refunded.

(iii) In case, the candidate withdraw his candidature after the last date of admission for any reason or unforeseen circumstances. The candidate/ guardian shall deposit full fees for 4½ years of the duration of the course. Fee once deposited will not be refunded in any circumstances.

7. Take off your eyeglasses for your photo.
8. Photograph should be taken wearing a white apron / lab coat
9. Use an off-white background.
10. Submit a high-resolution photo that is not blurry, grainy, or pixilated.
11. The correct size of a passport photo is 4.5 Cm X 3.5 Cm
12. Printed on matte or glossy photo quality paper
13. Do not digitally change the photo
14. You cannot submit a damaged photo with holes, creases, or smudges
