In exercise of the powers conferred by Sections 25(i) and 35(4) of NMC Act, 2019, the approval of PGMEB, NMC is hereby conveyed for grant of **Recognition against increased intake of 03 to 08 seats & Renewal of Recognition of 03 (01 & 01 to 03) seats of MD(Anesthesiology) qualification in respect of students being trained at Shri Guru Ram Rai Institute of Medical & Health Sciences, Dehradun under Shri Guru Ram Rai University, Dehradun, Uttarakhand**, under the following terms and conditions, as contained in the Post Graduate Medical Education Regulations, 2000:
