
Sir/Madam,

In exercise of the powers conferred by Sections 25(i) and 35(4) of NMC Act, 2019, the approval of PGMEB, NMC is hereby conveyed for grant of **Recognition of MD(Respiratory Medicine) qualification for 02 seats in respect of students being trained at Shri Guru Ram Rai Institute of Medical & Health Sciences, Dehradun under Shri Guru Ram Rai University, Dehradun, Uttarakhand**, under the following terms and conditions, as contained in the Post Graduate Medical Education Regulations, 2000:

- (i) The recognition so being granted herein, shall be valid for a maximum period of 05 (five) years from the year 2022, upon which it shall have to be renewed.
- (ii) The procedure for 'Renewal of Recognition' shall be same as applicable for the award of recognition.
- (iii) Failure to seek timely renewal of recognition as required in sub-clause (i) supra shall invariably result in stoppage of admissions to the concerned Post Graduate Course of the said institute.

2. The approval for Recognition of MD(Respiratory Medicine) qualification for 02 seats is granted subject to applicability of amendments in NMC Regulations from time to time.
